- Work is ongoing in the process of compiling a database of contacts in the region that will be shared with the communities

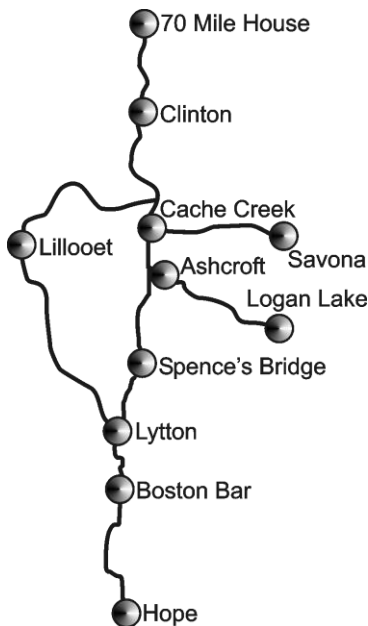
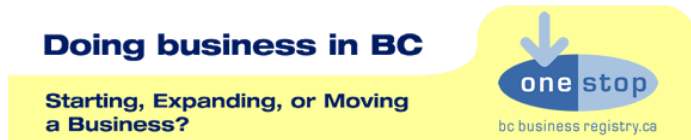
About Community Futures

Community Futures Development Corporation of Sun Country receives funding support from Western Economic Diversification (WD) to assist it in delivering its programs. The organization is **NOT** a government department or agency, although it often delivers services for all levels of government. The organization collaborates with government, corporate and community partners in order to deliver programs locally. Some of these programs include:

Located at 310 Railway Avenue in Ashcroft, the CFDC of Sun Country services a large geographical area that stretches from 70 Mile House in the north to Hope in the south and from Logan Lake in the east to Gold Bridge in the west. The service area covers approximately 35,000 square kilometers and the region's population is approximately 25,000.

The corporation offers a variety of entrepreneurial programs, business counseling, loan programs and business information to community members interested in expanding or starting their own business.

In addition to providing financial and technical support to small business in our area, CFDC of Sun Country is active in delivering a wide range of community economic development programs which benefit local and regional small business.

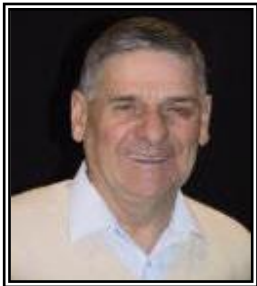
Scott Medlock, Resident of Hope

Director

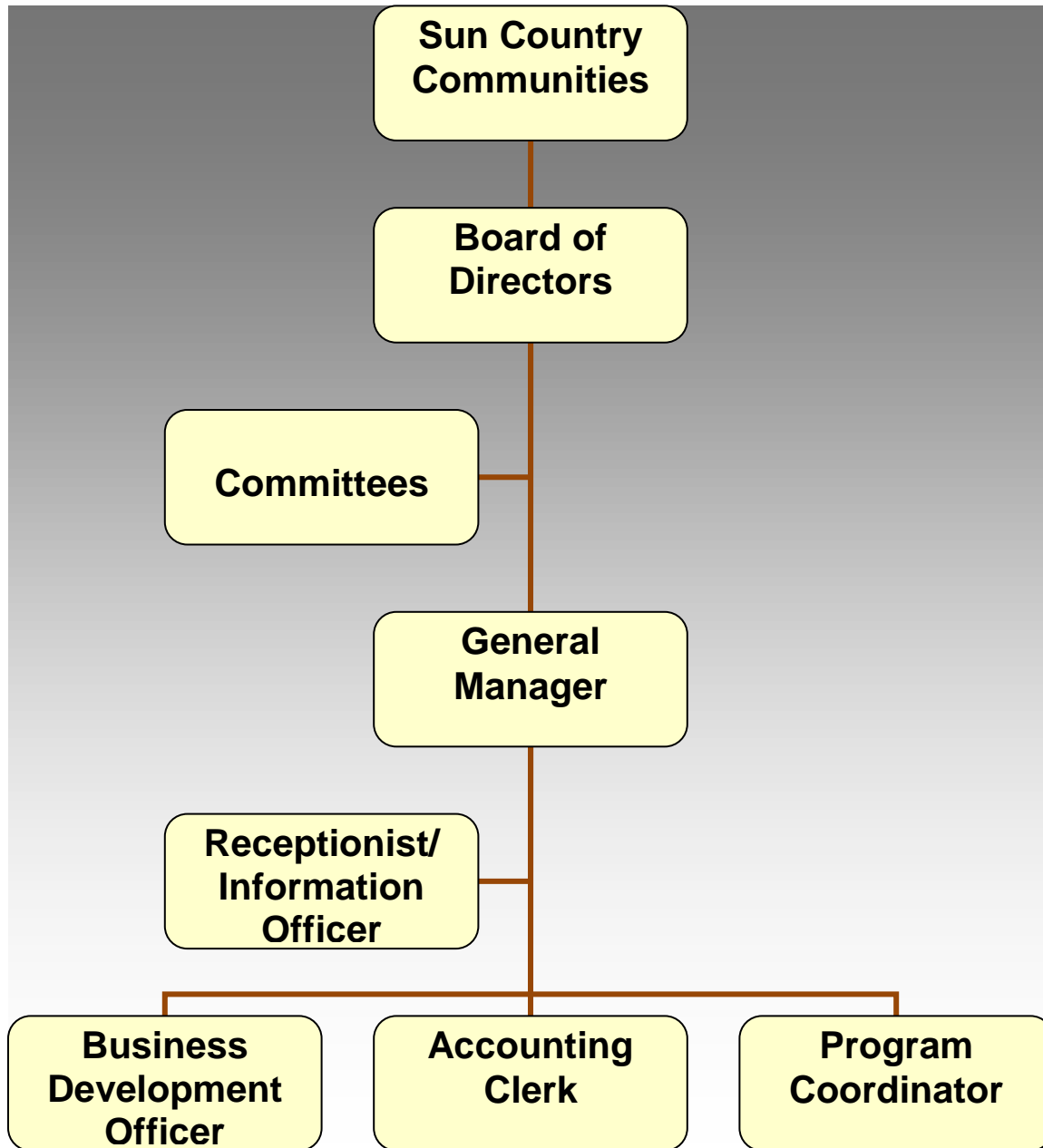

CFDC of Sun Country Organizational Chart



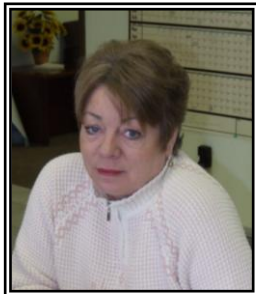

Presentations are made to village councils, chambers of commerce, community organizations and interested groups on a regular basis in order to establish, foster and maintain community partnerships with other agencies, stakeholders and service providers within the region.

CFDC of Sun Country also assists organizations with accessing funding from a variety of sources. Over the past year, the CFDC has been successful in acquiring and/or leveraging CED program funding in the Sun Country region. Some of the projects initiated, completed or participated in during the past year include:

- Planning sessions for Hope Station & Community Arts Council
- Community Responses to Crystal Methamphetamine for the communities of Ashcroft, Clinton and Logan Lake
- Trails to a Healthy Community for the community of Ashcroft and area

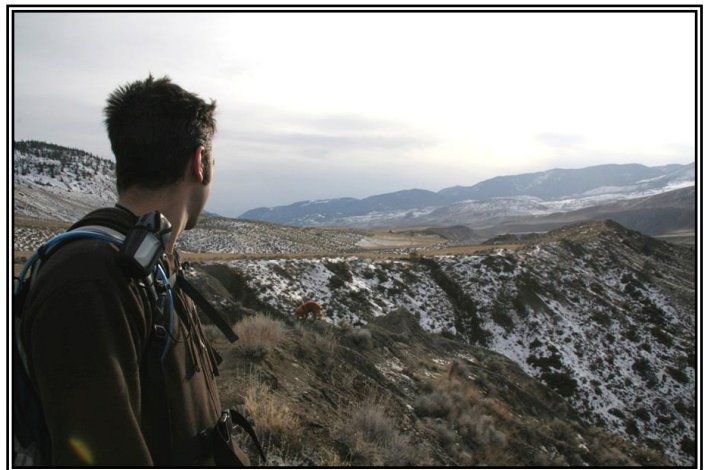


CED Projects

TRAILS to a Healthy Community

“TRAILS to a Healthy Community” was a joint effort between Community Futures of Sun Country, The Union of British Columbia Municipalities and the City of Kamloops.

The Program Coordinator for Sun Country worked with a number of volunteers from Ashcroft in the completion of Trails to a Healthy Community-Phase 1. The goal of this project was to build awareness of trails in the area and promote healthy living. Fifteen trails have been completed. These consisted of not only maps with the GPS, but written descriptions as well.





The high school was instrumental in helping with the “high school to downtown trail” project. Students completed five signs, which the Village volunteered to erect from the area of the high school to downtown. In addition a workshop for the hand held GPS device was facilitated which was a huge

success with 15 people in attendance. Not only was the workshop a great learning tool, it also brought a lot of positive attention to the project. The hiking guide that was put together is just a stepping stone and there are already plans to take it to the next level by adding more trails on a regular basis.



Community Responses to Crystal Methamphetamine



CFDC of Sun Country in partnership with the Villages of Ashcroft and Clinton and the District of Logan Lake have come together to provide relevant information on methamphetamine to youth and the communities. The program was designed to raise awareness about prevention strategies, drug use indicators, long term effects, and the risks associated with drug use-particularly crystal methamphetamine.



A number of theatre productions were presented throughout the region using tools such as improvisation and music to voice the dangers of crystal meth. The local high schools and community halls served as venues for the performances of “*Cranked*”, “*Meth*” and “*Protect Your Family*”.

Resource materials regarding crystal methamphetamine have been made available for use in the community libraries and high schools. Each community library is stocked with books, DVDs, and pamphlets and each high school has a variety of information cards and brochures.
